Upon receipt of this application for membership, we will send you a packet with a Personal Instruction Form (**PIF**) and step-by-step directions for completing and filing it with one of our contract mortuaries.

Be sure to keep a copy of your completed PIF for your personal files, and give one to your executor or next of kin.

When it comes time for final arrangements, your representative contacts the OMA contract mortuary that you have designated. The funeral director there will carry out your requests.
