ADDENDUM “A” - PACKAGE DESCRIPTIONS

Effective September 1, 2017

- B – 1 Direct Burial; No Service.....\$1,165.00**
Includes basic services of funeral director & staff; transfer of deceased to funeral home (within 25 mile radius); care and handling of deceased, including refrigeration; an all-wood, unfinished casket meeting the minimum requirements of the cemetery; private delivery by service vehicle to local cemetery (within 25 mile radius); OMA Records fee.*
- B – 2 Simple Graveside Service Without Embalming or Visitation.....\$1,595.00**
Includes basic services of funeral director & staff; transfer of deceased to funeral home (within 25 mile radius); care and handling of deceased, including refrigeration; coordination & direction of graveside service at cemetery; vinyl memorial book; memorial folders (100); acknowledgement cards (25); a 20 gauge steel, non-gasketed casket (silver or bronze color), or a comparable casket of equal or greater value; transportation by service vehicle to local cemetery (within 25 mile radius); OMA Records Fee.*
- B – 3 Traditional Funeral Service in Funeral Home Chapel with Burial.....\$2,935.00**
Includes basic services of funeral director & staff; transfer of deceased to funeral home (within 25 mile radius); care and handling of deceased, including embalming or refrigeration; preparation for viewing; use of funeral home facilities for visitation and funeral service; staff for supervision of visitation periods; coordination and direction of funeral ceremony in funeral home chapel; vinyl memorial book; memorial folders (100); acknowledgement cards (25); a 20 gauge steel, non-gasketed casket (silver or bronze color), or a comparable casket of equal or greater value; transportation by service vehicle to local cemetery (within 25 mile radius); OMA Records Fee.*
- C – 1 Direct Cremation; No Service.....\$ 845.00**
Includes basic services of funeral director & staff; transfer of deceased to funeral home (within 25 mile radius); care and handling of deceased, including refrigeration; crematory fee; an enclosed, rigid, combustible container meeting the minimum requirements of the crematory; and delivery by service vehicle to local crematory (within a 25 mile radius); OMA Records Fee.*
- C – 2 Direct Cremation with Memorial Service.....\$1,295.00**
Includes basic services of funeral director & staff; transfer of deceased to funeral home (within 25 mile radius); care and handling of deceased, including refrigeration; crematory fee; coordination & direction of memorial service at funeral home, church, or place of interment; vinyl memorial book; memorial folders (100); acknowledgement cards (25); an enclosed, rigid, combustible container meeting the minimum requirements of the crematory; and delivery by service vehicle to local crematory (within a 25 mile radius); OMA Records Fee.*
- C – 3 Traditional Funeral Service in Funeral Home Chapel with Cremation.....\$3,095.00**
Includes basic services of funeral director & staff; transfer of deceased to funeral home (within 25 mile radius); care and handling of deceased, including embalming or refrigeration; preparation for viewing; use of funeral home facilities for visitation and funeral service; staff for supervision of visitation periods; coordination and direction of funeral ceremony in funeral home chapel; vinyl memorial book; memorial folders (100); acknowledgement cards (25); choice of either a Batesville Newpointe Oval Top Embossed Grey Cloth-covered Herculite Casket or Solid Hardwood “Rental” Casket; transportation by service vehicle to local crematory (within 25 mile radius); crematory fee; OMA Records Fee.*

1. *The above package costs **do not** cover certified copies of the death certificate, or the \$20.00 Oregon State Filing Fee (this fee is not charged for deaths occurring outside of the State of Oregon).
 2. The term “Basic Services of Funeral Director and Staff” is defined as: “Personnel available 24 hours a day, 365 days a year to respond to initial call; arrangement conference; coordinating service plans with cemetery, crematory, and/or other parties involved in the final disposition of the deceased; clerical assistance in the completion of various forms associated with a funeral; securing and recording the death certificate and disposition permit; overhead, such as facility maintenance, equipment and inventory costs; insurance and administration expenses, and governmental compliance.”
 3. A \$95.00 additional charge will be assessed if the removal of the deceased takes place outside of normal business hours, which are defined as 8:00 AM to 5:00 PM, Monday through Friday. This charge is not included with pre-paid arrangements, but is collected, when applicable, at the time of death.
 4. If members select a casket from the funeral home’s regular Casket Price List, a \$350.00 credit is issued for the casket that is included in the above packages.
